## 1. Objective and scope of the mission

In follow-up to previous support and co-operation, MEPA Waste Management Department had requested urgent exchange and capacity-building on implementation issues related to Extended Producer Responsibility in Waste Management (see listed themes in mission request of 19 Dec 2023, annex 1).

For those waste streams for which Extended Producer Responsibility regulations are already in force (Waste Electrical and Electronic Equipment, Batteries, Tires and waste oils) the capacity-building focused on implementation issues including reporting and data management procedures, while the current regulatory discussions concern packaging and End-of-Life Vehicles for which the regulations are still in preparation.

Since Georgia is now a EU candidate country, also the relevant EC Decisions on reporting for specific waste streams are also relevant to be introduced.

Three days of discussions and capacity-building with the team of the Waste Management Department at MEPA.

## 4. Main results of the mission

On basis of presentations by the international experts, the level of understanding of MEPA staff was increased on the following issues:

### 4.1. Packaging and Packaging Waste

Key requirements for implementing Extended Produces Responsibility for Packaging and Packaging Waste were presented and discussed - nationwide system in Georgia, regulatory and technical requirements, basic collection infrastructure in municipalities

## 4.2. End of Life Vehicles

Regarding End of Live Vehicles, financial and economic aspects of EPR introduction were discussed, as well as responsibilities of different authorities regarding collection of abandoned ELVs.





### 4.3. Waste Information System

MEPA updated on developments and open issues regarding the waste information system on packaging and other waste

### 4.4. Co-ordination Office for Packaging

The role of a Coordination Office for Packaging was explained according Austrian experience, and the relevant options for Georgia were discussed.

#### 4.5. EC Reporting Decisions on Waste Streams

The international experts explained the EC reporting decisions on waste streams which will become mandatory for Georgia upon EU accession – their logic, structure and implementation, interlinkage with Waste Statistics Regulation.

### 4.6. Calculation Methodology for Packaging Waste

The methodology for calculation of annual amounts of packaging and packaging waste was introduced, and their function as basis for defining and assessing recycling targets explained.

Introductory text for website:

### Extended Producer Responsibility in Waste Management – Capacity-Building for EU Accession

In European Union countries, Extended Producer Responsibility has been introduced in the management of specific waste streams to assure higher collection and recycling rates according to the requirements of the Waste Framework Directive and in view of developing a more circular economy.

Extended Producer Responsibility is also a tool to promote the overall transition towards a more sustainable and circular economic model.

For new EU candidate countries the development of adequate legislation and effective implementation rules and procedures for Extended Producer Responsibility is a major challenge which requires international support and sharing of successful EU country experience. Since the beginning of the programme, the EU4ENV W&D expert team provides advice to the waste department of the Environment Ministry in **Georgia** on implementation of already adopted Extended Producer Responsibility regulations on Waste Electrical and Electronic Equipment, Batteries, Waste Oils and Tires.

Focus on work with the Georgian colleagues is on those waste streams for which Extended Producer Responsibility regulations are still in development:

- Packaging nationwide system in Georgia, regulatory and technical requirements, basic collection infrastructure in municipalities, role of Coordination Office for Packaging (Austrian experience and options for Georgia)
- End of Live Vehicles financial and economic aspects of EPR introduction; responsibilities of different authorities regarding collection of abandoned ELVs
- Waste information system on packaging and other waste update on developments and open issues, incl. circular economy indicators
- EC reporting decisions on waste streams logic, structure and implementation, interlinkage with Waste Statistics Regulation
- Methodology for calculation of annual amounts of packaging and packaging waste, as basis for recycling targets; circular economy indicators

From side of the international expert team, one specific focus will be the requirement for nation-wide coverage of EPR systems, following the successful Austrian practice and not yet fully adopted by Georgia.

Since Georgia is now a EU candidate country, also the relevant EC Decisions on reporting for specific waste streams must be introduced.
